WHAT YOU NEED TO KNOW

LONG TERM MONTHLY RENTALS ARE OFTEN REQUIRED:

- A lease contract
- A guarantor
- A security deposit and the payment of the first month rent
- Administrative fees (often one month's rent excluding charges)
- Home insurance

SIMPLIFIED

LEXICON

LEASE CONTRACT:

Contractual document establishing the responsibilities of the lessor and the tenant

THE GUARANTOR OR THE SOLIDARITY GUARANTEE:

Physical or legal person committing to pay the rent in the event of default by the tenant.

and receive your “**VISA-VISALE**”. To properly complete your VISALE application, do not hesitate to consult **our user manual on the Campus France website**.

Some residences work with “**Garant Me**” <https://www.garantme.fr> if you are not eligible for Visale or if this device is not recognized by the lessor.

GUARANTEE DEPOSIT:

Amount requested at the entrance of the premises to cover any possible damage, often equivalent to one month's rent (returnable on departure under certain conditions).

HOME INSURANCE:

Insurance to be taken with a bank or an insurance organization and cover you in the event of water damage, fire, thefts, etc.

NOTICE:

Notice period to which you must comply to leave your accommodation (as a general rule: 1 month).

HOUSING TAX:

Tax to be paid by the tenant occupying an apartment on January 1 of the tax year

HOUSING AID:

The **CAF** (Caisse d'Allocation Famille) can pay you housing aid in the form of ALS or APL:

SOME ADVICE FOR YOU:

Beware of rents that are too cheap - Beware of pictures that are too attractive - Never send money to a private individual before visiting the accommodation - Avoid paying rents in advance

Check with your school to find out about possible partnerships with the host
